The Financial Information Services Laws, 5782 -2021 (hereinafter: the "**Law**") permits the banks' customers to provide "financial information service providers" "authorized access" to "financial information", as these terms are defined in the Law, which are held by the bank, for using services from the same financial information service provides, all subject to the provisions of the Law. In light of the foregoing and subsequent to the "Application to Open an Account and the General Terms for the Management of the Account", in the form agreed upon with the account holder's whose details are specified above (hereinafter; the "**Limited Partnership**") and Bank Hapoalim Ltd.
